Forespørgsler til servicen

Der er 3 primære inputs til servicen:

- `OrderedAtPharmacyIdentifier`: Lokationsnummeret på det udleverende apotek
- `PackedAtPharmacyIdentifier`: Lokationsnummeret på det pakkende apotek
- `ProductionDateTime`: Produktionstidspunktet (Et tidspunkt mellem tidsfrist for ændringer & periodens start)

Man skal som udgangspunkt angivet enten `OrderedAtPharmacyIdentifier` eller `PackedAtPharmacyIdentifier` FMK vil derefter fremsøge dosisdispenseringskort med akut periode(r) som er bundet til det angivne apotek, enten direkte på dosisdispenseringskortet eller via en pakkegruppe. Alternativt kan begge apoteker angives og FMK fremsøger herved kun kort som er bundet til begge disse apoteker. `ProductionDateTime` er valgfri at benytte, benyttes den ikke vil FMK bruge tidspunktet hvor forespørgslen finder sted.
